




The Methods section should describe the study design and methods (including the study setting and dates, patients/participants with inclusion and exclusion criteria, patient samples or animal specimens used, the essential features of any interventions, the main outcome measures, the laboratory methods followed, or data sources and how these were selected for the study), and state the statistical procedures employed in the research. The Results section should comprise the study results presented in a logical sequence, supplemented by tables and/or figures. Authors should avoid excessive self-citation, and should only self cite if this is appropriate for the article in question. The responsibility for accuracy of references lies with the reference style approved by ICMJE as given in the "Recommendations for the Conduct, Reporting, Editing and Publication of Scholarly Work in Medical Journals" which is also popularly known as Vancouver style. Editorial Process The journal follows double blind peer-review process. All articles (including invited ones) submitted to the Journal undergo initial review by the Editor/associate editor and articles that are outside the scope of Journal or are not in the Journal format are excluded. Later each article is reviewed by at least two reviewers. The time to first decision is usually less than 6 weeks. As per the policy of the Journal, an Editor or Editorial Board member, who is either author of a manuscript or belongs to the same institution as any of the authors, is not assigned that manuscript and is not involved in decision-making regarding its publication. Reviewers/Editorial Board members should decline the invitation to review a manuscript which is submitted by authors from their institution.
